Chapter 13 bankruptcy, also called the wage earner's bankruptcy or reorganization bankruptcy, is one of the two most popular types of consumer bankruptcies (the other one is Chapter 7 bankruptcy ). In Chapter 13 bankruptcy, you keep your property and repay some or all of your debts over a three or five year period.
