The gain is not taxed when it occurs in a year where you are in the zero percent capital gains tax bracket. The zero percent tax rate on capital gains applies to people in the 15% marginal tax rate or below. In 2018, that applies to married tax filers with taxable income up to \$77,400, and single tax filers with taxable income up to \$38,700.
